#### I - Introduction

- 1.1 Overview of the M.Sc. Nursing Course
  - The Colleges of Nursing included in this Prospectus offer M.Sc. Nursing Degree Program of 2 year duration as specified by Kerala University of Health Sciences, (KUHS), approved by Indian Nursing Council & Kerala Nurses and Midwives Council.
- 1.2 The Private Nursing College Management Association in Kerala has decided to introduce a separate selection procedure for admission of candidates in the Management Quota to the M.Sc. Nursing course as per the direction of the Honorable Supreme Court of India in its judgments dated 31<sup>st</sup> October 2002, dated 14<sup>th</sup> August 2003 and 4<sup>th</sup> January 2007.
- 1.3 This prospectus contains the rules and regulations for selection and admission to the seats to be filled by the Managements of Self- Financing Colleges of Nursing for the year 2025-2026.
- 1.4 This prospectus is subject to modification/addition/deletion as may be deemed necessary by the Association and subject to the Judgments of Honorable Courts of law.

#### II – Institutions and Number of Seats

- 2.1 No. of seats: The annual intake of each college is shown in the annexure.
- 2.2 (a) All the candidates admitted shall pay the fees fixed by Government of Kerala / Fee Regulatory Committee and as approved or modified by competent authorities.
- (b) The list of institutions under the Private Nursing College Management Association in Kerala, the number of seats and other details are given in Annexure.
  - (c) Admission to courses in the institutions for which approval/permission has not been obtained will be subject to the approval/permission from the Nursing Council/University/Government.

#### III - Eligibility for Admission

- 3.1 Academic:
  - (i) Candidates who have passed regular BSc Nursing course with minimum 55% aggregate of any University in Kerala or any other University recognized as equivalent to it by Kerala University of Health Sciences.
  - ii) a) B.Sc. Nursing candidates should have one year experience/internship after Registration with Nursing Council.
  - b) Post Basic BSc. Nursing qualified candidates shall have one year experience prior or after Post Basic BSc Nursing and registration in the respective State Nursing Council.

- iii) Candidates should have valid registration from Kerala Nurses & Midwives Council (KNMC). Those candidates who have registration with other State Council should produce KNMC *registration at the time of admission*.
- (v) **Eligibility Certificates:** Candidates who have passed their qualifying examination from University outside Kerala State shall produce the certificate of recognition and equivalency of qualifying examination from KUHS Thrissur. This should be furnished at the time of interview for admission.

#### IV – How to apply

4.1 Application for admission to course M.Sc. Nursing course can be registered only online through a single application. The provision for applying online is available at the website www.pncmak.in Submission of more than one application by a candidate will lead to rejection of the candidature

#### 4.2 **Application Fee:**

- (i) The application fee will be Rs.1200/- for all candidates, payable through online by using Credit/Debit/Internet Banking facility. Application submission will be completed only after successful payment of Application fee through online.
- (ii) If the payment is debited and you are not guided to the second stage please inform us to <a href="mailto:help@pncmak.in">help@pncmak.in</a> with your login details or email-id or mobile number, we will provide you the required help within 24Hrs.
- (iii) Application fee once remitted will not be refunded in any circumstances.

#### 4.3 Availability of Prospectus

(i) Prospectus can also be downloaded from www.pncmak.in. However, it will not be available by post or from any the office of the any Nursing Colleges.

#### 4.4 Remittance of Application Fee and Submission of Application Form

- (i) There will be three stages for the submission of Application form and all stages are mandatory. Candidates shall complete all the stages of submission as per the time schedule which will be notified through the website/media.
  - Stage 1- Entering candidate details online and creating a login id and password.
  - Stage 2- Online Payment of Application fee using Credit/Debit/Internet Banking facility.
  - **Stage 3 -** Completion of Application submission with College of 10 options. No need to send any printout of the data to any office.

#### (ii) Remittance of Application Fee and Submission of Application is detail.

- (i) Candidate shall visit the official website <u>www.pncmak.in</u> and click the link "Admission".
- (ii) The personal details of the candidate have to be filled in the page thus obtained and saved

- (iii) Candidate are requested to create a login id and Password for future references.
- (iv) Click 'SAVE' Button, Candidate will be guided to Payment Screen. Application fee can be paid by Debit/Credit/Internet Banking facility.
- (vii) On successful payment of Application fee Candidate will be guided to Next Page, Upload the Photo of the candidate (in JPEG format up to 30 KB size).
- (viii) Submit your 10 preferred college as your option and Click Save and Final Confirmation.

#### V Preparation of Merit List

- 5.1 **Merit list:** Merit list of eligible candidates will be prepared by the college on merit basis from among the applications received by the educational agency.
- 5.2 **Validity of the merit list:** The published merit list will be valid till 31-01-2026 or the date up to which the merit list shall be kept alive in terms of instruction/direction of competent authority.
- 5.3 Inclusion in the merit list will not entitle the applicant eligible for admission to the course, unless the applicant satisfy the rules regarding the eligibility for admission and other conditions as laid down in the Prospectus.
- 5.4 Furnishing of false information/particulars would result in the forfeiture of the candidature as well as cancellation of admission to the course, and in addition, will attract the relevant provisions of criminal law of the land.

#### VI Selection by Centralised Allotment Process(CAP)

- The Centralized Allotment Process for Management Seats in Private Self financing Colleges for which the allotment is made through a Single Window System (SWS). The allotment to various colleges for M.Sc. Nursing will be done by SWS under the supervision of the Admission Supervisory Committee(ASC). The allotments will be strictly based on the options exercised by the candidate, the rank lists prepared and published in the website based on the marks secured by the candidate for the seats.
- 6.2 **Community Quota:** The selection of candidates by managements of minority community will be based on the specific directive of Honorable Supreme Court. (Percentage of seats reserved for minority community is shown in Annexure). All right of claim for eligibility relaxation or community claim shall be sustained with the required documents at the time of admission.

#### VII Admission & Payment of Fees

- 7.1 The selected candidates will be informed through SMS in to the registered mobile no with us ..
- 7.2 The students shall pay all fees of the 1<sup>st</sup> year of the course at the time of admission which will not be refunded.

Tuition fee-Rs.1,10,000/- Other fee-Rs.55000/-, Caution Deposit-Rs.10000 (refundable) and other fees due to statutory bodies(KUHS,KN&MC & INC) as and when notified.

All other fees will be as per order no FRC FRC 50/25/NURSING/AMCSFNCK/PNCMAK Fee regulatory committee for medical education in Kerala.

Selected Candidates should remit Rs 10000/- (part of the Tuition fee) through online for acceptance of the admission in the allotted seat. If the amount is not remitted within the time prescribed. The application of the Candidate will be removed from the admission process.

7.3 If any candidate discontinues the course, after closing of admission as notified by the authority, the candidate has to pay the full fee of the remaining course(2 yrs). The Collection of liquidated damages shall be as per the final decision of the AFRC or Court of Law.

#### **VIII -Special Instructions**

- a. Ragging: Ragging in any form is strictly prohibited in all member colleges. All the member colleges are committed to abolish ragging in their campuses. Hence any student who indulges in any form of ragging will be subjected to penal action as per provisions of law. Also the student will be expelled from the college as detailed in the law concerned and as per Honorable Supreme Court of India directions in this regard.
- b. Use of Mobile Phone: Use of Mobile Phone by students are not allowed in the classes.
- c. Any other items not specifically covered in this prospectus will be decided by the undersigned, and his decision shall be final.
